Sub:- Issue of Essentiality Certificate under Rule 44 of  
the Delhi School Education Act, 1973.

Sir,

With reference to your application on the subject  
cited above, I am directed to convey the permission of the  
Director of Education, Delhi to your society to establish  
a new school from class I to XII (Co-Edn.) without aid in  
Vasant Kunj area of District South subject to the following  
conditions:-

1. That the provision of DSEAR, 1973 and the rules framed thereunder shall be observed by the society.
2. That the management of the school will fulfil all the conditions, laid down under Rule 50 and will provide all the facilities given in Rule 51 of DSEAR, 1973 to the institution.
3. That the Management of the school will get the scheme of management approved from the department immediately.
4. That only qualified and trained teachers will be appointed at prescribed Govt. scales alongwith all allowances will be paid to the teaching and non-teaching staff through crossed cheque.
5. That the Management of the school will not ask for grant-in-aid from the department.
6. That the school will not run for the profit of any individual association or group of persons.
7. That in case at any time the Management of the school is unable to run the school, moveable and non-moveable property of the school will be transferred in the name of Director of Education, Delhi.

8. That the management of the school will apply for grant of recognition of the school under DSEA and Rules, 1973 separately and recognition will not be granted unless statutory provision of Sec.4(1) (a) to (f) read with 50 and 51 are fulfilled.
9. That all the recognised classes shall be run at one place only.
10. That the management of the school will obtain land from the DDA in the name of the society through Directorate of Education, Delhi.
11. That the school shall be run under the banner of Virendera Bhatnager Sansthan, A-I, Ring Road, N.D. SE-I New Delhi and suitable funds will be made available for the construction of suitable building on the land allotted to the society, as declared as per the specifications of the department within a period of 3 years and adequate and sufficient accommodation of 12 sq. ft. per student shall be provided for class room. The normal size of the class room is 24' X 20'. No other activities other than education shall be run.

If recognition for the proposed school is not sought after fulfilling all the above conditions within a period of 3 years, this permission to run a new school shall be treated as cancelled.
